A meeting on preparations for EEF 2021 held in Vladivostok

During his working trip to Primorye Territory, Deputy Prime Minister – Presidential Plenipotentiary Envoy to the Far Eastern Federal District Yury Trutnev held a meeting on the preparation for the Eastern Economic Forum (EEF). The issues of investors' and government officials' participation in the 2021 Forum, readiness of Vladivostok's urban infrastructure, as well as epidemiological safety measures were discussed.

New agglomerations, smart cities and green transformation discussed at the first online session in the course of preparation for the EEF

The first online session in the course of preparation for the Eastern Economic Forum was held on 30 April 2021. The event was organized by the Government of the Sakhalin Region, the Ministry for the Development of the Russian Far East, the Far East Development Corporation, and the Roscongress Foundation. Participants of the session discussed topical issues related to the development of the region and the international agenda.

The discussion was mainly focused on the development of territories directly connected to the sea: through a coastline, a system of bays, or seaports. It is suggested that integration makes it possible to realize the tourist potential of the territories, to perform the renovation of regional and local facilities, and to provide an incentive for industrial development.

As part of the agglomeration process, the prospects for creating an ecopolis in Korsakov are under consideration. The town may benefit from a multimodal international logistics centre based at the seaport; a special economic zone governed by international law, with special registration regime; a scientific and educational centre for ocean economics (including a campus for 9,000 students); an innovative multicultural centre with a comfortable urban environment and housing with a total area of about 1 million sq. metres.

Russia assumes Chairmanship in the Arctic Council for 2021–2023

Chairmanship of the Arctic Council has passed over to Russia for the next two years. The ceremony took place at the Ministerial meeting of the eight Arctic States in Reykjavik. Icelandic Foreign Minister Guðlaugur Þór Þórðarson handed over the ceremonial gavel – a symbol of the Council Chairmanship – to his Russian counterpart Sergei Lavrov.

As part of its Arctic Council Chairmanship in 2021–2023, Russia intends to develop cooperation with the participating countries in four key areas: population of the Arctic, including the indigenous peoples of the North; protection of the Arctic environment, including climate change; social and economic development of the region; and strengthening the role of the Arctic Council as the main platform for multilateral cooperation in high latitudes. This is stated by the Concept of the Chairmanship of the Russian Federation in the Arctic Council in 2021–2023, approved by Mikhail Mishustin.

The Concept is aimed at implementing the tasks set by the Russian President in the Fundamentals of State Policy of the Russian Federation in the Arctic and the Strategy for Developing the Russian Arctic Zone and Ensuring National Security through 2035.

Murmansk Region to simplify allocation of Arctic Hectares as of 1 August

This becomes possible due to the decision to extend the Far Eastern Hectare programme to the entire Russian Arctic zone. The simplified procedure includes simultaneous allocation and provision of a land lot, so that the process would take no longer than 45 days. The lot is provided without bidding for a 5-year term for free use. Should the land be reclaimed within this term, it may be purchased or leased. Possible land use options include construction of residential housing or countryside homes, agriculture, and tourism.

The land lots will be distributed by the regional government: Ministry of Natural Resources, Environment and Fisheries (forest land lots) and the Ministry of Property Relations. The largest territories are designated in the Kola region.

The Arctic Hectare programme in the Murmansk Region is to be launched on 1 August 2021. More than 700,000 hectares of land are to be allocated.

This was stated by Deputy Prime Minister Dmitry Chernyshenko during a meeting on the development of tourism in the Kamchatka Territory, the Valley of Geysers and other Protected Areas of Russia. "Three Volcanoes Park", a modern multifunctional tourist and recreational complex, is going to be created with the participation of the Tourism.RF corporation in Kamchatka. The Park will be cultivated in accordance with the principles of sustainable development and Environmental, Social and Corporate governance (ESG).

State Duma committee approves facilitating the access to the Russian Arctic zone for small businesses

The State Duma Committee on Economic Policy sponsors the bill designed to facilitate the access of small businesses to the Russian Arctic zone. The legislation removes the requirement to make capital investments in the construction, modernization or reconstruction of real estate for small businesses applying for the Arctic zone residency. At the same time, the specification of economic activities that are not subject to these requirements should be determined by the Government of the Russian Federation.
